Later, as Vice Chair of Investment & Corporate Banking, where he served as a senior advisor in advancing key client relationships. His experience with BMO culminated in a Board Chair role for Nesbitt Burns, Inc., the largest subsidiary of BMO Financial Group, which Peter held until retiring from the organization in 2023.
